**ORDINANCE NO. 1 OF 2015**

**AN ORDINANCE OF WILLISTOWN TOWNSHIP, CHESTER COUNTY, AMENDING CHAPTER 133 OF THE CODE OF ORDINANCES OF WILLISTOWN TOWNSHIP PERTAINING TO TRAFFIC AND PARKING REGULATIONS, BY PROHIBITING PARKING ON CERTAIN TOWNSHIP ROADS DURING THE SPECIAL PAPAL VISIT BY ORDER OF THE TOWNSHIP.**

**BE IT AND IT IS HEREBY ENACTED** by the Board of Supervisors of Willistown Township, Chester County, as follows:

**Section 1.** Chapter 133 of the Code of Ordinances of Willistown Township, Chester County, "Vehicles and Traffic", Article IV, "Miscellaneous Provisions" is hereby amended by adding a new Section 133-21, as follows:

**§133-21. Special Temporary Parking Regulations.**

No person shall park a vehicle at any time upon any of the streets or parts thereof described below during the special Papal visit commencing 12:00 AM September 25, 2015 and ending at 11:59 PM September 27, 2015, when posted as a designated no parking tow-away zone by order of the Board of Supervisors and the Police Department:






**Section 2.** This Amendatory Ordinance shall be effective five (5) days from the date of enactment.
