2. 730 Monument Road (54-2-41)

TR Moser attended this evening's meeting as the applicant for 730 Monument Road Subdivision. The property owners, Brook Drinkwater and Bill Lucas, were also present. The plans propose a 37 lot subdivision with 35 new homes. The property consists of 62 acres of land as well as historic resources located on the property. The historic resources will be subdivided into their own lots and the barn is to be demolished, due to structural issues.

The Historical Commission visited the site on August 16<sup>th</sup> 2018. After the visit, the Commission determined that it was not in favor of the demolition of the barn. The applicants will resubmit plans and present them at a later meeting with these changes.

3. 955 Garrett Mill Road (54-6-91)

Brian Jarratt, Apex Construction, attended this evening's meeting as the applicant for 955 Garrett Mill Road. The property owner, Lida Wright, was also present. After reviewing the plans, the Commission determined that they were not complete. The applicant will submit the missing items prior to the next meeting.

b. 810/820/826 Providence Rd, Radnor Hunt
